A Message from True the Vote to Non Citizens

MENSAHE MULA SA "TOTOONG BOTO" PARA SA MGA HINDI PA U.S. CITIZENS

We understand that there may be people who are talking with you about voting in an American election.

Nauunawaan po namin na may mga katao na gusto kayong kausapin tungkol sa pagboto sa American Election.

Please know that these people are misleading you. And they're putting you and your family at risk.

Maunawaan po ninyo na inililigaw o inililihis po kayo ng mga kataong ito, at inilalagay kayo at inyong mga pamilya sa panganib.

The consequences of being charged with and prosecuted for vote fraud can be severe and long-lasting for non-citizens. It's essential for individuals to understand the laws regarding voting eligibility and to avoid engaging in any illegal activities that could jeopardize their immigration status and future opportunities in the United States.

Ang kahihinatnan po ng panlilinlang o panloloko sa pagboto ay hindi kaayon-ayon sa inyong buhay. Mahalaga po na maintindihan ninyo ang mga batas tungkol sa pagiging karapatdapat na pagboto para maiwasan na ma enganyo sa illegal na aktibidad. Sa ganyan po ay hindi malalagay sa panganib ang inyong imigrasyon status. Pati na ang mga oportunidad na kasama ng inyong imigrasyon status na darating pa sa mga susunod na panahon.

If a non-citizen is charged with vote fraud and prosecuted in the United States, they can face several serious consequences, including:

Kung hindi po kayo mamamayan ng Estados Unidos at ikaw ay kinasuhan ng panloloko sa pagboto, kailangan mong harapin ang malubhang kahihinatnan ng iyong panloloko katulad ng:

1. ***Criminal Charges:*** *Vote fraud is a felony offense in many jurisdictions, punishable by significant fines and imprisonment. The exact penalties vary depending on the severity of the offense and the laws of the state where the crime occurred.*

1. **Kasong Kriminal:** Ang pandaraya sa pagboto ay krimen sa lahat ng hurisdiksyon, na ang parusa ay malaking multa at kulong.

2. ***Deportation:*** *Non-citizens convicted of vote fraud may face deportation or removal proceedings. Committing a felony offense can trigger immigration consequences, potentially leading to deportation and the loss of legal status in the United States.*

2. **Deportasyon:** Ang hindi mamamayan ng Estados Unidos ay puwedeng mahatulan ng deportasyon at kawalan ng legal na katayuan sa Estados Unidos.

3. ***Ineligibility for Citizenship:*** *A conviction for vote fraud can render a non-citizen ineligible for future immigration benefits, including naturalization and citizenship. Immigration authorities may deny or revoke applications for citizenship based on a criminal record involving vote fraud.*

3. **Kawalan ng Karapatan sa Citizenship:** Kapag nahatulan kayo ng panloloko sa pagboto sa eleksyon, mawawalan na kayo ng karapatan na maging U.S. Citizen.

4. ***Loss of Voting Rights:*** *In addition to facing legal consequences, individuals convicted of vote fraud may lose their right to vote in future elections, even if they eventually become U.S. citizens. This loss of voting rights can have long-term implications for their civic participation and engagement in American elections.*

4. **Kawalan ng Karapatan sa Pagboto:** Bilang karagdagan, puwede pa rin kayong mawalan ng karapatan na maging botante kahit na kayo ay maging U.S. Citizen balang araw.

5. **Stigma and Reputation Damage:** *Being charged with and convicted of vote fraud can damage a person's reputation and standing in the community. It may also lead to social stigma and discrimination, making it difficult to rebuild trust and credibility.*

5. **Estigma at Pagkasira ng Reputasyon:** Ang panloloko sa pagboto ay puwedeng makasira sa inyong katayuan sa lipunan at stigma at reputasyon.

6. **Financial Consequences:** *In addition to fines imposed as part of the criminal sentence, individuals convicted of voter fraud may incur substantial legal expenses for defense attorneys, court fees, and other related costs.*

6. **Pinansiyal na Kahihinatnan:** Bilang karagdagan sa mga multa, magkakaroon po kayo ng malaking gastos sa abogado para kayo ay edepensa, bayad sa hukuman, at iba pang mga kaugnay na gastos.
