

Talking Points/FAQ Responses Re: Elections Executive Order

March 26, 2025

Please use these approved responses when answering voters' questions about the recent executive order. If they ask a more detailed question than what is covered in these responses, please ask for their contact information and ask Mitch or Bill for more information before responding.

I am currently registered to vote. How does this order affect me? Do I need to do anything to remain registered?

No voters in Colorado need to take any action to remain registered. There is no immediate impact to any Colorado voter's registration.

If that fact were to change, voters can expect detailed communications and instructions from their county clerk's office about what steps they would need to take.

Will this change Colorado's mail ballot voting model, or anything else about how we vote?

No. The order does not address any aspects of Colorado's voting technology, equipment, or voting methods. Much of the order pertains to voter registration, such as accepting REAL ID at the time of registration. Documents included in the REAL ID classification are already required in Colorado for someone to register to vote.

Does this order affect voting, or registering to vote?

It applies to both. However, it would not change anything about how Coloradans currently register to vote, who is eligible to registered to vote, or what type of equipment or voting systems are used in Colorado.

The COGOP reorganizational meeting on March 29th included plenty of "robust discussion". Arapahoe County was an important part of the meeting with 29 voting members out of over 450. Many of those members also helped

on the teller and credentialing committees. Some Arapahoans counting ballots had no other obligation to be there, showing that Republicans care enough about transparent elections to show up, arrive early and leave late (more than 12 hours for many!)

Though voting and debate took hours, counting the ballots took the team only minutes, and the fully auditable result was unchallenged because the entire count was open to watchers from all sides. As the saying goes, trust everybody, but count the money (or ballots) yourself!

Just over a month after demonstrating hand counting for one of the most complex ballots you would ever see (ACGOP bonus member election), many Republicans from Arapahoe and other counties drove to Weld County to

demonstrate the system for fellow Republicans. In Weld there were fewer candidates and fewer choices, but emotions were high, since this meeting was a re-do of a previous meeting which failed to come to a conclusive result. At issue was a lack of transparency

in counting results, plus disagreement on whether new precinct leaders could vote. Further complicating the meeting, some members attended - and voted - online.

Despite these difficulties and other obstacles such as a short lead time, a new teller team leader, uncertainty in how some votes would be taken, and a late opening of the building for setup, the multi-county team shone. ...

Finding Friendly Voters

Currently we spend a lot of time and money on unaffiliated voters, trying to figure out which way they lean, and whether they even vote or were just signed up as unaffiliated by default by the Motor Vehicle Department when they turned 16.

Meanwhile, whether we like it or not, demographic data is collected about all of us all day, every day, and that data is available. Jeff Young (a.k.a. "Data Jeff") is working with Secretary Jean Baugh to compare that data with voter rolls, much as companies

do for their marketing, to figure out which people will listen best to our messages. We can sort out not only who leans Republican, but why. Knowing which issues they agree with us on will help us understand which talking points to start with.

With this information, we don't need to talk like Democrats to "reach the unaffiliated" - we can show the most-likely-to-vote-Republicans they really were Republicans all along, might as well join us, and by the way might want to learn the rest of the story on some other issues!







Protect Access to Gender Affirming Health Care

The League of Women Voters of the United States believes that the federal government shares with other levels of government the responsibility to provide equality of opportunity for education, employment, and housing for all persons in the United States regardless of their race, color, gender, religion, national origin, age, sexual orientation, or disability. The League of Women Voters supports access to adequate health care with funding by state and federal monies where necessary. LWVCO supports access to affordable, quality in- and out-patient behavioral health care, including needed medications and supportive services, for all people.

LWVCO supports access to behavioral health care that is integrated with, and achieves parity with, physical health care.


Colorado House Bill 25-1309: Protect Access to Gender-Affirming Health Care aims to codify protections for gender-affirming healthcare within the state. The bill mandates that all state-regulated health benefit plans provide coverage for medically necessary gender-affirming care, as determined by a licensed physical or behavioral health-care provider. This encompasses a wide range of services, including medical, behavioral health, mental health, psychiatric, habilitative, surgical, therapeutic, diagnostic, preventive, rehabilitative, and supportive care related to the treatment of gender dysphoria.


Additionally, the bill exempts prescriptions for testosterone from the state's Prescription Drug Monitoring Program (PDMP) tracking requirements and restricts access to archived records of such prescriptions. This measure is designed to protect patient privacy and prevent potential misuse of prescription data.

By enacting HB25-1309, Colorado seeks to reinforce its commitment to health equity and ensure that transgender and gender-diverse individuals have consistent access to necessary medical treatments without facing insurance barriers or discrimination. The bill reflects the state's dedication to upholding the rights and well-being of all its residents, particularly in the realm of essential healthcare services.

Case Summary

LWV, LWV of Arizona, NAACP, Hispanic Federation, OCA - Asian Pacific American Advocates, and Asian and Pacific Islander American Vote filed a federal lawsuit arguing that President Trump's Executive Order 14248, which ordered the EAC to require documentary proof of citizenship on the federal voter registration form, threatened to withhold funds from states allowing post-election day receipt of mail ballots, and invited DOGE to assist in voter list maintenance, among other provisions, was an illegal order beyond the President's powers under the United States Constitution and federal law.

Executive Orders are an instrument by which the President of the United

States may exercise authority lawfully granted to him by Article II of the United States Constitution and Congress. To quote Justice Robert Jackson, prosecutor at the Nuremberg Trials,

When the President acts pursuant to an express or implied authorization of Congress, his authority is at its maximum, for it includes all that he possesses in his own right plus all that Congress can delegate.... When the President takes measures incompatible with the expressed or implied will of Congress, his power is at its lowest ebb, for then he can rely only upon his on own constitutional powers minus any constitutional powers of Congress over the matter


Know Your Rights!


RISE FOR FREEDOM







The order threatens withholding federal funding for states that fail to comply. Media outlets from all over the country, including Arizona, California, Colorado, Connecticut, Florida, Illinois, Louisiana, Michigan, Nevada, Ohio, Oregon, Rhode Island, Vermont, Washington, and Wisconsin have posted stories about how the EO may impact voting in their states and how state and local elections officials are reacting to the news.

New Hampshire: The passed a bill this week allowing voters to request that their ballot be hand-counted by cities and towns, even if their polling place uses machine counting. House Bill 154 would allow any voter to make that request to a poll worker; if they did so, town election officials would be required to deposit the ballot in an "auxiliary compartment" of the ballot-counting machine to be hand-counted after the polls closed. HB 154 passed on the House floor in a contested voice vote with no discussion. But during a vote in the House Election Law Committee, Republicans said the vote was meant to give voters the ability to cast their ballots the way they wanted to. Others, including House Election Law Committee Chairman Ross Berry, a Weare Republican, said they supported giving voters the choice but advised voters to consider whether they wanted their ballots hand-counted in the first place. "I will issue a word of caution: When you do this, when you exercise this ... you're saying, I want

somebody who's been up for 16 hours straight to pull out my ballot and read it amongst other ballots that are either put in that bin or had errors," Berry said. "My experience in the recounts shows that the machines are far more accurate than the people."

Georgia: U.S. District Judge J.P. Boulee has thrown out a lawsuit that challenged whether the state could take over county election oversight and prohibit ballot photography. Boulee ruled that the plaintiffs, led by the election security group Coalition for Good Governance, failed to show they had been harmed by the provisions in Georgia's 2021 voting law. Boulee did not rule on the merits of the lawsuit. Boulee had previously put the ballot photography ban on hold in 2021, finding that such far-reaching restrictions violated free speech protections. That ruling allowed photographing ballots while they were being counted, recounted or audited. It remained illegal to photograph completed ballots in polling places while voting was underway. But Boulee's ruling this week ends the case, and with it, his prior decision on ballot photography. "The court's decision affirms the integrity of Georgia's elections and upholds the state's ability to allow every lawful voter the opportunity to cast a ballot," said Secretary of State Brad Raffensperger. "Since the passage of Senate Bill 202, Georgia has conducted multiple successful elections with record voter turnout, proving that election integrity measures and voter access can go hand in hand."

An Update on the Caltech Election Integrity Project

Elections research continues in 2025 with focus on AI in Elections

It's hard to believe that we are almost halfway through 2025 and that it has been almost a year since the team at the <u>Linde Center for Science</u>, <u>Society</u>, and <u>Policy at Caltech (LCSSP)</u> officially launched <u>The Caltech Election Integrity</u> <u>Project</u> back in July 2024 with <u>my last by-line in electionlineWeekly</u>.

We originally intended for this program to conclude next month, but we have extended our research and dissemination of findings through at least the end of 2025 so that we can further engage with election practitioners and other election community stakeholders.

Federal Update: Back in 2021, President Joe Biden signed Executive Order 14019 giving federal employees up to four hours of paid time off in order to vote and serve as nonpartisan poll workers. In 2022, the Office of Personnel Management issued guidance requiring agencies to provide federal employees with up to four hours of administrative leave to vote in federal, state, local, tribal, and territorial elections. Additionally, OPM clarified that employees could also use up to four hours of administrative leave per year to serve as a non-partisan poll worker or observer. In March of 2025, President Donald Trump signed Executive Order 14248 revoking the paid time off. According to an article in Government Executive, agencies have begun notifying federal workers about the new policy. "Effective immediately, Forest Service employees are not authorized to use administrative leave to vote or participate in voting related activities," said a message received by employees and obtained by Government Executive. Other USDA employees reported being told verbally they could no longer use that form of paid time off for voting. The Interior Department has apparently removed implementation guidance on the leave-forvoting policy from its website. The Forest Service told employees they are still allowed to request taking their own personal vacation time for voting purposes.



Colorado just lost \$250 million in federal funding for public and behavioral health -- money slated, in part, for childhood vaccines and infectious disease lab capacity, just as measles spreads in nearby Texas. This is just the beginning of promised federal cuts.

As federal funds are cut, other states' legislators can decide to cut state services and/or education funding, or raise tax revenue and preserve what the state does for its citizens. Colorado lawmakers finalize budget proposal. Here's what they cut to close \$1.2B gap - and what they didn't.



The cuts will enable the state to absorb the rising costs of Medicaid and fully fund K-12 for another year. But they didn't eliminate the state's structural deficit, which will require ongoing cuts for years to come.

Colorado budget writers voted Wednesday night to introduce a state spending plan that eliminates a number of social programs, dramatically reduces transportation spending and leaves the state's new K-12 funding formula in jeopardy in order to close a \$1.2 billion shortfall.

The Joint Budget Committee also cut into the operations of state agencies, while shifting some costs onto local governments in order to balance the annual budget for the 2025-26 fiscal year, which begins July 1.






The first deals with student headcount. Currently, the state counts students on a rolling, four-year average, which wards off enrollment swings.



As you know, earlier this year, President Trump issued Executive Order 14248, which aimed to make several big changes to how states run federal elections. To review, the order would have:

- Required voters to provide documents proving their U.S. citizenship when registering to vote federally.
- Forced public assistance agencies to verify citizenship before handing out voter registration forms
- Directed federal agencies to go after states that count mail ballots received after Election Day.
- Tied federal election funding to states agreeing to stricter ballot receipt deadlines.

Nineteen states, including Colorado, sued to block these changes, arguing that the President overstepped his legal authority and was trying to override powers that belong to Congress and the states.

Earlier this morning, a federal judge in Massachusetts agreed with the states and issued a preliminary injunction blocking these parts of the Executive Order.

The Court's Reasoning:

- The President can't change federal election laws on his own. Congress has already set rules through
 laws like the National Voter Registration Act (NVRA), the Help America Vote Act (HAVA), and the
 Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). None of those require proof-ofcitizenship documents or give the federal government control over state ballot receipt deadlines.
- The proposed requirements would have imposed major burdens on states. Colorado and other states would have had to completely overhaul their registration processes, train staff, create new voter education materials, and deal with likely voter confusion and disenfranchisement, especially for voters who don't have easy access to passports, birth certificates, or other citizenship papers.
- The ballot receipt deadline changes overreached. The court rejected the administration's argument that

states violate federal law by counting ballots received after Election Day, as long as the ballots were mailed on time under state law. Colorado, for example, already allows timely-mailed UOCAVA ballots to arrive after Election Day and still be counted.

What This Means for Colorado:

- Since Colorado was one of the states that sued, it is directly protected by the court's order.
- Colorado can continue to run its elections under existing state law:
 - Voters won't have to submit citizenship documents.
 - Public assistance agencies won't have to pre-screen voter registrations for citizenship.
 - o Ballots that arrive shortly after Election Day (but were mailed on time) can still be counted.
 - Federal election funding that Colorado receives under HAVA is not at risk.

Is This Ruling Binding Everywhere?

- Technically, the ruling only applies to the states involved in the lawsuit.
- For Colorado, though, this ruling fully protects the state while the case moves forward.
- If this decision is appealed and upheld at higher courts (like the U.S. Supreme Court), it could eventually apply nationwide.

Bottom Line:

Colorado election officials don't need to make any changes as a result of Executive Order 14248 — at least for now. The federal government cannot require Colorado to adopt these new rules while this injunction is in place.

Colorado and other states would have had to completely overhaul their registration processes, train staff, create new voter education materials, and deal with likely voter confusion and disenfranchisement, especially for voters who don't have easy access to passports, birth certificates, or other citizenship papers.
- The ballot receipt deadline changes overreached. The court rejected the administration's argument that

states violate federal law by counting ballots received after Election Day, as long as the ballots were mailed on time under state law. Colorado, for example, already allows timely-mailed UOCAVA ballots to arrive after Election Day and still be counted.

What This Means for Colorado:

- Since Colorado was one of the states that sued, it is directly protected by the court's order.
- Colorado can continue to run its elections under existing state law:
 - Voters won't have to submit citizenship documents.
 - Public assistance agencies won't have to pre-screen voter registrations for citizenship.
 - o Ballots that arrive shortly after Election Day (but were mailed on time) can still be counted.
 - Federal election funding that Colorado receives under HAVA is not at risk.

Is This Ruling Binding Everywhere?

- Technically, the ruling only applies to the states involved in the lawsuit.
- For Colorado, though, this ruling fully protects the state while the case moves forward.
- If this decision is appealed and upheld at higher courts (like the U.S. Supreme Court), it could eventually apply nationwide.

Bottom Line:

Colorado election officials don't need to make any changes as a result of Executive Order 14248 — at least for now. The federal government cannot require Colorado to adopt these new rules while this injunction is in place.




President Trump Signs Executive Order on Voter Registration Verification Requirements

On March 25, President Donald Trump issued an executive order entitled "Preserving and Protecting the Integrity of American Elections." The order includes directives that could impact federal-state information sharing practices and strengthens documentary evidence and data verification requirements associated with proof of citizenship for purposes of registering to vote. Among other instructions, the executive order:

- Directs the Election Assistance Commission to require documentary proof of United States citizenship alongside the mail voter registration form.
 - o For purposes of compliance this means including a copy of:
 - a valid federal or state government-issued photo identification that indicates that the applicant is a United States citizen or identification accompanied by proof of United States citizenship.
 - an official military identification card that indicates the applicant is a citizen of the United States.
 - a REAL ID compliant identification document that "indicates the applicant is a citizen of the United States."
 - a United States passport.
- Directs DHS, with the Administrator of the Department of Government Efficiency (DOGE), to review and compare each state's voter registration list with federal immigration databases and requested state records, including through subpoena
- Directs the Attorney General to prioritize restricting non-citizens from registering to vote, including through use of:
 - o Databases or information maintained by the Department of Homeland Security;
 - o State-issued identification records and driver license databases; and
 - o Similar records relating to citizenship.
- Directs the Department of Homeland Security (DHS) to ensure that state and local officials have access to federal systems for verifying the citizenship or immigration status of individuals registering to vote or who are already registered without a fee.
- Directs the Attorney General to enter into information sharing agreements with the chief state election official or multimember agency of each state to provide the Department of Justice with detailed information on all suspected violations of state and federal election laws.
- Directs the Attorney General to prioritize enforcement of federal election laws in those states unwilling to enter into an information sharing agreement and review potential withholding of grants and other funds to state and local governments for law enforcement purposes.

The executive order has the authority to instruct federal executive agencies in the execution of law, but legal challenges to the order are expected. Members may want to consider this prior to making operational changes to their programs. AAMVA will continue to monitor the progress of the directives associated with the executive order and notify members accordingly.







Good morning everyone,

As you know, earlier this year, President Trump issued Executive Order 14248, which aimed to make several big changes to how states run federal elections. To review, the order would have:

- Required voters to provide documents proving their U.S. citizenship when registering to vote federally.
- Forced public assistance agencies to verify citizenship before handing out voter registration forms
- Directed federal agencies to go after states that count mail ballots received after Election Day.
- Tied federal election funding to states agreeing to stricter ballot receipt deadlines.

Nineteen states, including Colorado, sued to block these changes, arguing that the President overstepped his legal authority and was trying to override powers that belong to Congress and the states.

Earlier this morning, a federal judge in Massachusetts agreed with the states and issued a preliminary injunction blocking these parts of the Executive Order.

The Court's Reasoning:

- The President can't change federal election laws on his own. Congress has already set rules through laws like the National Voter Registration Act (NVRA), the Help America Vote Act (HAVA), and the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). None of those require proof-of-citizenship documents or give the federal government control over state ballot receipt deadlines.
- The proposed requirements would have imposed major burdens on states. Colorado and other states would have had to completely overhaul their registration processes, train staff, create new voter education materials, and deal with likely voter confusion and disenfranchisement, especially for voters who don't have easy access to passports, birth certificates, or other citizenship papers.
- The ballot receipt deadline changes overreached. The court rejected the administration's argument that
 states violate federal law by counting ballots received after Election Day, as long as the ballots were

Good morning everyone,

As you know, earlier this year, President Trump issued Executive Order 14248, which aimed to make several big changes to how states run federal elections. To review, the order would have:

- Required voters to provide documents proving their U.S. citizenship when registering to vote federally.
- Forced public assistance agencies to verify citizenship before handing out voter registration forms
- Directed federal agencies to go after states that count mail ballots received after Election Day.
- Tied federal election funding to states agreeing to stricter ballot receipt deadlines.

Nineteen states, including Colorado, sued to block these changes, arguing that the President overstepped his legal authority and was trying to override powers that belong to Congress and the states.

Earlier this morning, a federal judge in Massachusetts agreed with the states and issued a preliminary injunction blocking these parts of the Executive Order.

The Court's Reasoning:

- The President can't change federal election laws on his own. Congress has already set rules through laws like the National Voter Registration Act (NVRA), the Help America Vote Act (HAVA), and the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). None of those require proof-of-citizenship documents or give the federal government control over state ballot receipt deadlines.
- The proposed requirements would have imposed major burdens on states. Colorado and other states would have had to completely overhaul their registration processes, train staff, create new voter education materials, and deal with likely voter confusion and disenfranchisement, especially for voters who don't have easy access to passports, birth certificates, or other citizenship papers.
- The ballot receipt deadline changes overreached. The court rejected the administration's argument that
 states violate federal law by counting ballots received after Election Day, as long as the ballots were
 mailed on time under state law. Colorado, for example, already allows timely-mailed UOCAVA ballots to
 arrive after Election Day and still be counted.

Good morning everyone,

As you know, earlier this year, President Trump issued Executive Order 14248, which aimed to make several big changes to how states run federal elections. To review, the order would have:

- Required voters to provide documents proving their U.S. citizenship when registering to vote federally.
- Forced public assistance agencies to verify citizenship before handing out voter registration forms
- Directed federal agencies to go after states that count mail ballots received after Election Day.
- Tied federal election funding to states agreeing to stricter ballot receipt deadlines.

Nineteen states, including Colorado, sued to block these changes, arguing that the President overstepped his legal authority and was trying to override powers that belong to Congress and the states.

Earlier this morning, a federal judge in Massachusetts agreed with the states and issued a preliminary injunction blocking these parts of the Executive Order.

The Court's Reasoning:

- The President can't change federal election laws on his own. Congress has already set rules through laws like the National Voter Registration Act (NVRA), the Help America Vote Act (HAVA), and the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). None of those require proof-of-citizenship documents or give the federal government control over state ballot receipt deadlines.
- The proposed requirements would have imposed major burdens on states. Colorado and other states would have had to completely overhaul their registration processes, train staff, create new voter education materials, and deal with likely voter confusion and disenfranchisement, especially for voters who don't have easy access to passports, birth certificates, or other citizenship papers.
- The ballot receipt deadline changes overreached. The court rejected the administration's argument that states violate federal law by counting ballots received after Election Day, as long as the ballots were mailed on time under state law. Colorado, for example, already allows timely-mailed UOCAVA ballots to arrive after Election Day and still be counted.

What This Means for Colorado:

- Since Colorado was one of the states that sued, it is directly protected by the court's order.
- Colorado can continue to run its elections under existing state law:
 - Voters won't have to submit citizenship documents.
 - Public assistance agencies won't have to pre-screen voter registrations for citizenship.
 - Ballots that arrive shortly after Election Day (but were mailed on time) can still be counted.
 - Federal election funding that Colorado receives under HAVA is not at risk.

Is This Ruling Binding Everywhere?

- Technically, the ruling only applies to the states involved in the lawsuit.
- For Colorado, though, this ruling fully protects the state while the case moves forward.
- If this decision is appealed and upheld at higher courts (like the U.S. Supreme Court), it could eventually apply nationwide.

Bottom Line:

Colorado election officials don't need to make any changes as a result of Executive Order 14248 — at least for now. The federal government cannot require Colorado to adopt these new rules while this injunction is in place.
