Please be advised that this office represents the Monmouth County Board of Elections in New Jersey, which is in receipt of your Saturday, October 11, 2025 request for certain records relating to Executive Order No. 14248. This request was logged the next business day, on Monday, October 13th.

Specifically, you requested:

[A]II records, communications, directives, or guidance created or received by your office since March 25, 2025, related to Executive Order 14248, titled *'Preserving and Protecting the Integrity of American Elections'*, including but not limited to:

- 1. Actions taken or planned to comply with, respond to, or evaluate the order.
- 2. Communications with federal agencies (including the Election Assistance Commission or Department of Justice) concerning implementation or challenges to the order.
- 3. Any internal analyses, meeting notes, or correspondence with state officials, election vendors, or other stakeholders related to voter roll verification, mail-ballot receipt deadlines, or documentary proof-of-citizenship requirements.
- 4. Additionally, please include any records, guidance, or communications your office has received from state or federal agencies in connection with Executive Order 14248.

Thank you for your response to our October 11, 2025 public records request regarding Executive Order 14248. We appreciate your acknowledgment and the time taken to review our submission.

However, we would like clarification regarding the denial of Point 1, which was cited as "not a valid request seeking readily identifiable government records." This point specifically requested:

"All records, communications, directives, or guidance created or received by your office since March 25, 2025, related to Executive Order 14248, titled *'Preserving and Protecting the Integrity of American Elections'*, including but not limited to actions taken or planned to comply with, respond to, or evaluate the order."

Could you please clarify what aspect of this request was determined not to be valid or readily identifiable under New Jersey's Open Public Records Act (OPRA)? We believe the request is appropriately narrow in scope — limited to records *created or received* by your office related to a single Executive Order — and we would appreciate any guidance that would allow us to refine or restate it in compliance with OPRA.
