The Board of Elections in the City of New York (BOE) is in receipt of your Freedom of Information Law (FOIL) request, dated October 14, 2025, which states:

"This request seeks all records, communications, directives, or guidance created or received by your office since March 25, 2025, related to Executive Order 14248, titled *'Preserving and Protecting the Integrity of American Elections'*, including but not limited to:

- 1. Actions taken or planned to comply with, respond to, or evaluate the order;
- 2. Communications with federal agencies (including the Election Assistance Commission or Department of Justice) concerning implementation or challenges to the order;
- 3. Any internal analyses, meeting notes, or correspondence with county officials, election vendors, or other stakeholders related to voter roll verification, mail-ballot receipt deadlines, or documentary proof-of-citizenship requirements.

Additionally, please include any records, guidance, or communications your office has sent to counties or local election authorities in connection with Executive Order 14248."

Be advised, FOIL requests are processed in the order in which they are received. Additionally, Board staff are currently focused on fulfilling the Board's statutorily mandated election activities for the November General Election, including conducting nine days of early voting, the rolling canvass, the post-election canvass, completing all required audits, and the ultimate certification of the election results. These important statutory functions of the Board require the full attention of staff to fulfill the agency's legal mandates.

Based on the foregoing and the estimated time it may take to search, sort, compile and review the records being requested, it is anticipated the assembly of any available documents will be completed on or before ninety days (90) days following the date of this notice. Please note, this timeframe may be modified depending on changing conditions.

Your request will be forwarded to the appropriate staff as soon as possible. When staff is available, a search for any responsive records will be conducted and the results will be sent to the Records Access Office. You will be contacted in writing and advised if any records responsive to your request are located and, if subject to disclosure, when they will be available for review.


Should you request copies of such records, pursuant to the New York State Public Officers Law \$87(1)(b)(iii), there is a fee of 25ϕ per photocopy of documents nine inches by fourteen inches or less. For larger documents, the actual cost of reproduction will be charged in accordance with Public Officers Law \$87(1)(c).

The BOE accepts cash, money order, or a corporate check made payable to the Board of Elections in the City of New York. Please be prepared to pay for the reproduction costs, if any, when you pick up the materials.

If your request is denied you may appeal this determination to the Board's FOIL Appeals Officers. Please see the Board's "Records Access Policy – FOIL Rules," which is located on the Board's website, for additional information regarding FOIL appeals.
