For the County to continue to process your request for records, we require additional information. Please provide the following:

As your request currently stands, it is too broad and vague for us to determine what records you are seeking. For the County to continue to process your request for records, we require additional information:

Please define the specific terms and sources you wish for us to use in determining "all" records, communications, directives, etc. as this list is overly broad and may return many documents greatly impacting the time required by staff to gather, review and redact as necessary.

Please remember that Tarrant County Elections Administration (TCEA) can only provide records received from within its own department. Other County Departments or 3rd parties or may have to contacted separately.

We can note, that a prior similar request was answered as "no records, communications, directives, notices or advisories responsive from either the Secretary of State or Texas Attorney General—dated on or after March 25, 2025—which states, suggests, confirms, or implies that Texas counties are not required to comply with President Donald J. Trump's Executive Order issued on March 25, 2025, or any other Executive Order issued by President Trump regarding election processes." I have updated that information specifically as it applies to the Elections Administrator (Clinton Ludwig) and the Assistant Elections Administrator (Troy Havard) and the answer has not changed through the date of this letter.

For an email or other electronic record search, is it possible to narrow the search to specific Tarrant County Elections employees? Most records searches are for the Elections Administrator (EA) and/or his Assistant Elections Administrator (AEA)? These are submitted to our IT/Security department which requires specific names and search terms. They will then give us an estimate of the time involved in the work. This will not include the review and redactions of personal or other information that may be required.

Requests for searches of other County Employees or representatives will have to be submitted to the Tarrant County District Attorney's office.

Please provide more information on item 3. Please clarify if you mean "additional work" specific to that which is defined in the Texas State code? As you know, Tarrant County has ongoing efforts/maintenance as required by code and would take place regardless of the Executive Order. Unless the Texas Code is amended to change specific ballot deadlines, Tarrant County will continue to work with the current Texas code.

Thank you for your patience and we look forward to more information to help us process your request.

Per Texas Government Code section 552.222, if a written response to this request for clarification or narrowing is not received within 61 days, your request is considered withdrawn.

Description of records requested:

To whom it may concern, Pursuant to applicable state public records laws, including any freedom of information or open records statutes in your jurisdiction, True the Vote respectfully submits this request for access to and copies of records as described below. This request seeks all records, communications, directives, or guidance created or received by your office since March 25, 2025, related to Executive Order 14248, titled *'Preserving and Protecting the Integrity of American Elections'*, including but not limited to: 1. Actions taken or planned to comply with, respond to, or evaluate the order; 2. Communications with federal agencies (including the Election Assistance Commission or Department of Justice) concerning implementation or challenges to the order; 3. Any internal analyses, meeting notes, or correspondence with county officials, election vendors, or other stakeholders related to voter roll verification, mail-ballot receipt deadlines, or documentary proof-of-citizenship requirements. Additionally, please include any records, quidance, or communications your office has sent to counties or local election authorities in connection with Executive Order 14248. True the Vote recognizes that portions of Executive Order 14248 are currently subject to judicial review and preliminary injunctions. This request is not intended to seek privileged legal materials but to understand what steps, if any, your office is taking to assess compliance, improve election integrity procedures, or prepare for potential implementation. We request that you provide all responsive records in electronic format, preferably as searchable PDF files transmitted by email to research@truethevote.org. We also respectfully request acknowledgment of this request within five (5) business days and full production of responsive records within the statutory period provided by your state's public records law. If you determine that portions of this request are exempt, please provide any segregable portions of responsive records and identify the specific legal basis for any withholdings. Thank you for your time and assistance.
